**SIGNIFICANT ACCOUNTING POLICIES AND NOTES FORMING PART OF  
FOREIGN FUNDS ACCOUNTS FOR THE YEAR ENDED ON  
31<sup>st</sup> MARCH 2019.**

**A. SIGNIFICANT ACCOUNTING POLICIES**

**1. *Background:*** Language and Learning Foundation was promoted as a public charitable trust by way of executing a deed of declaration of public charitable trust executed on 26.02.2015.

The main activities of the trust shall focus towards improving education and learning, as per the activities defined in the trust deed.

**2. *Basis of Accounting:*** The accounts are prepared on historical cost basis as a 'going concern'. Income and Expenses are accounted for on accrual basis following generally accepted accounting principles and practices and Accounting Standards issued by the Institute of Chartered Accountants of India for NGOs, wherever applicable, except where otherwise stated.

**3. *Donation:*** - Donations received during the period were recognized as income, on the basis of donation letters received from the donors.

**4. *Income taxes:*** Trust is registered under Section 12A of the Income tax Act, 1961 ('the Act') which exempts from taxes on income from property held under trust and voluntary contributions received. Accordingly, the income of Trust is exempt from tax, subject to the compliance of terms and conditions specified in the Income Tax Act, 1961.

**1. Pending Legal Case/Contingent Liabilities:** There are no legal cases pending or initiated during the year either by any individual or organization against Language and Learning Foundation.
